

**BEFORE THE CITY COUNCIL
FOR THE CITY OF LAFAYETTE, OREGON**

**Approving a rate schedule for Recology
Western Oregon, effective July 1, 2022**)

Resolution No. 2022-04

THE CITY COUNCIL (the "Council") OF THE CITY OF LAFAYETTE, OREGON (the "City") sat for the transaction of City business on Thursday, June 23, 2022 in the Council Chambers at City Hall.

WHEREAS, at the December 8, 2005 meeting, the Council adopted Ordinance 579, to become effective January 7, 2006, amending, in its entirety, the original exclusive franchise for the collection and disposal of solid waste in the City which was granted by Ordinance No. 398, to City Sanitary & Recycling Service, DBA Western Oregon Waste, (now DBA Recology Western Oregon) McMinnville, Oregon ("Franchisee"); and

WHEREAS, the franchise agreement establishes a procedure for setting, by separate resolution, the rates that Franchisee may charge in the City; and

WHEREAS, the franchise agreement establishes an Operating Ratio Range which, if financial data indicates is not being met, allows franchisee to request rates that will bring them back within the range, or it may instead apply an annual cost of living adjustment to the rates based upon the percentage change in the Consumer Price Index (CPI-U) for the 'West B/C' during the past year; and

WHEREAS, on May 20, 2022, Franchisee submitted a rate increase request for waste disposal services.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Lafayette, Oregon that:

1. As authorized by Ordinance No. 579, and to be effective July 1, 2021, Franchisee's rates shall be adjusted as set forth in the rate sheet attached as "Exhibit A," which by this reference is made a part hereof as if set forth at length herein.
2. This Resolution is effective immediately.

ADOPTED by the City Council this 23rd day of June, 2022.
