**RESOLUTION 2022-13**

THE CITY COUNCIL (the "Council") OF THE CITY OF LAFAYETTE, OREGON (the "City") sat for the transaction of City business on Thursday, December 8, 2022 in the Council Chambers at City Hall.

**WHEREAS**, a General Election was held on November 8, 2022, in the City of Lafayette, Yamhill County, Oregon; and

**WHEREAS**, eligible voters of the City of Lafayette considered the election of City Officers and Measure 36-218, to Allow City to Expend Funds to Construct a Water Reservoir; and

**WHEREAS**, the Abstract of Votes for the November 2022 General Election was prepared and certified by the Yamhill County Clerk for the County of Yamhill, Oregon. The results have been filed in the office of the City of Lafayette's Election Official.

**NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAFAYETTE, OREGON, AS FOLLOWS:**

**SECTION 1.**

HILARY MALCOMSON was duly elected MAYOR for a two-year term beginning January 1, 2023 and ending December 31, 2024.

JOSEPH CARSWELL, MICHAEL SHAW, and JO JOHNSON were each duly elected COUNCILOR for a four-year term beginning January 1, 2023 and ending December 31, 2026.

**SECTION 2.** The City of Lafayette's Elections Official is hereby directed to issue Certificates of Election to the persons declared in Section One above.

**SECTION 3.** Measure 36-218 Allowing the City to Expend Funds to Construct a Water Reservoir was approved.
