RESOLUTION NO. 2023-07

THE CITY COUNCIL (the "Council") OF THE CITY OF LAFAYETTE, OREGON (the "City") sat for the transaction of City business on Thursday, June 13, 2022 at 6:30 p.m. in the Council Chambers of Lafayette City hall.

WHEREAS, the Lafayette City Council has, pursuant to Lafayette Municipal Code (LMC) Section 4.155 and 4.007, the authority to set rates for users of its water and sewer utilities; and

WHEREAS, the Council has previously adopted Resolution 2022-08, establishing new water rates effective July 20, 2022, and

WHEREAS, the Council has previously adopted Resolution 2019-07, establishing new water rates effective June 13, 2019, and

WHEREAS, the City Council commissioned a water rate study conducted by the Oregon Association of Water Utilities and accepted that study on April 13, 2023; and

WHEREAS, a rate increase and updated structure is required to adequately fund operating costs, debt payment, and maintain existing infrastructure.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Lafayette, Oregon as follows:

Section 1: the water rates for FY2024 shall be set as shown in Exhibit "A"

Section 2: the updated rate structure shall take effect on July 20, 2023.


This resolution shall be and is effective from and after its passage by the Council and until June 30, 2024.
